

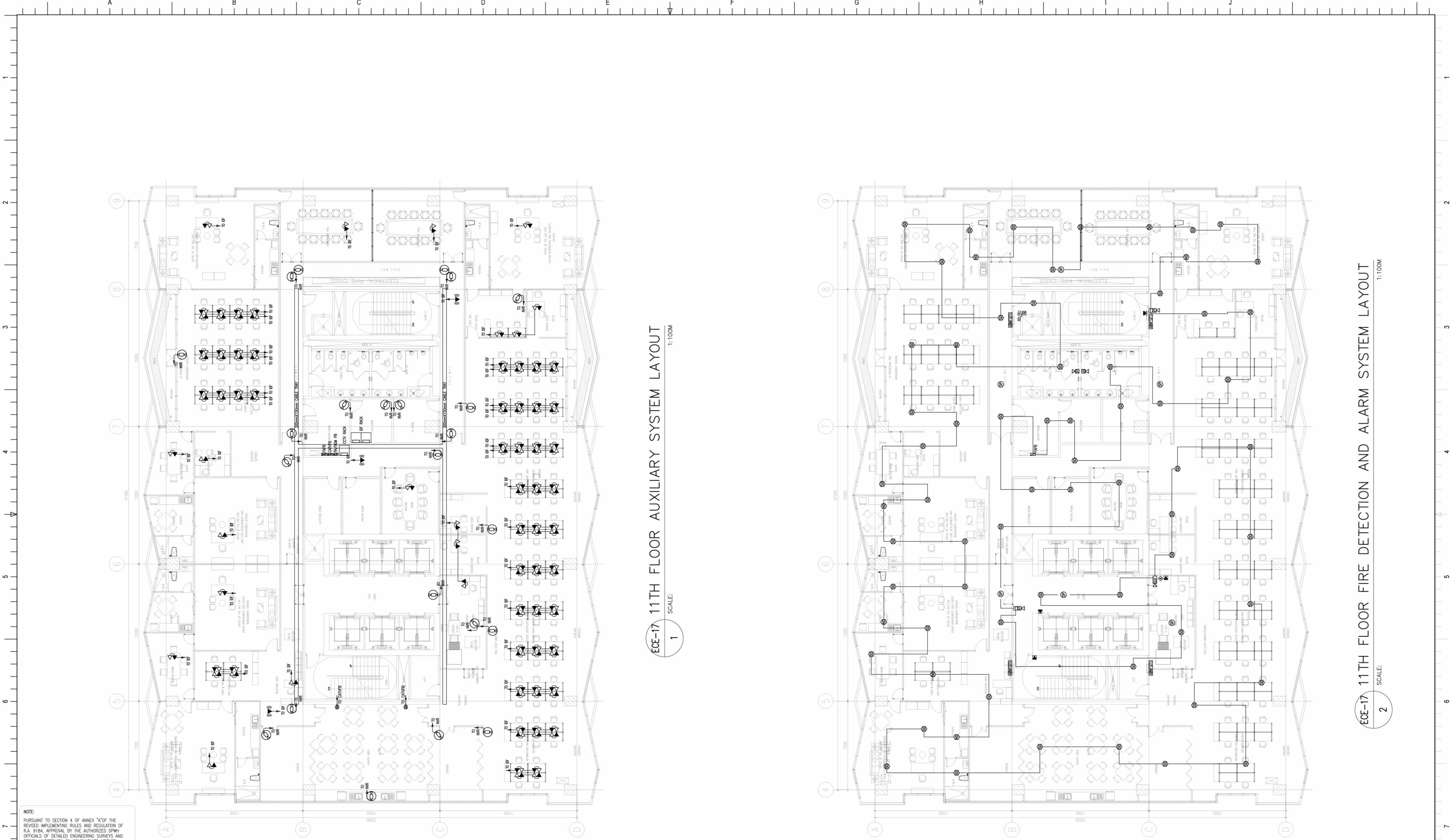
ECC-16 10TH FLOOR AUXILIARY SYSTEM LAYOUT
