**RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (R07-BAC)
RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THAT THE
PROCUREMENT OF LEASE OF VENUE INCLUDING ACCOMMODATION WITH
MEALS FOR THE TRAINERS AND MEALS FOR THE PARTICIPANTS DURING THE
CENTRAL VISAYAS REGIONAL STATISTICS COMMITTEE COMPLEMENTARY
TRAINING ON DATA VISUALIZATION BE AWARDED TO ONE CENTRAL HOTEL &
SUITES**

WHEREAS, the Philippine Statistics Authority (PSA)-Regional Statistical Services Office 7 needs to procure Venue including Accommodation and Meals (AM & PM snacks, complimentary breakfast, buffet lunch, and dinner) for the Trainers and Meals (AM and PM snacks, and buffet lunch) for the Participants during the Central Visayas Regional Statistics Committee Complementary Training on Data Visualization on 24-26 October 2023;

WHEREAS, an approved Purchase Request with **PR No. 0700-2023-09-078** was received by the R07-BAC Secretariat;

WHEREAS, this procurement was done by lot;

WHEREAS, this procurement was done through an Alternative Method of Procurement- Lease of Venue;

WHEREAS this procurement was not posted on the Philippine Government Electronic Procurement System (PhilGEPS) and Philippine Statistics Authority (PSA) website;

WHEREAS, Request for Quotations (RFQs)/Bid Forms was sent to PhilGEPS registered establishments;

WHEREAS, before the closing date of submission, the secretariat received four (4) quotations from 1.) Hotel Elizabeth; 2.) One Central Hotel & Suites; 3.) Bai Hotel Cebu; 4.) DepEd Ecotech Center -a government-owned establishment which is not available; and was acknowledged by Harolds Evotel and St. Mark Hotel as enumerated in the abstract of the quotation;

WHEREAS the Region 7 Bids and Awards Committee (R07-BAC) with the presence of a member of the Technical Working on Group (TWG) conducted an online deliberation on **19 October 2023** via Messenger;

WHEREAS during the deliberation, Region 7 Bids and Awards Committee (R07-BAC) the quotation submitted by **One Central Hotel & Suites** is considered as the Lowest Calculated Quotation (LCQ) subject to TWG verification for the internet speed;

WHEREAS, on 20 October 2023, the TWG conducted the verification through ocular visit and interviewed their Sales Manager, Mr. Michael Español. According to him they can comply with the required internet speed of 100 mbps and that they can also provide a Local Area Network (LAN) cable for the training;

WHEREAS, based on the made verification with TWG Report No. 2023-10-04, the Technical Working Group has ascertained that One Central Hotel & Suites is responsive and can comply with the laid technical specifications;

WHEREAS on 20 October 2023, the Region 7 Bids and Awards Committee (R07-BAC) with the presence of the TWG members conducted another online deliberation via Google Meet;

WHEREAS, upon careful evaluation and based on the result of the TWG report, the R07-BAC declared the quotation submitted by **One Central Hotel & Suites** as Lowest Calculated and Responsive Quotation (LCRQ);

NOW, THEREFORE, be it resolved as it is hereby resolved that the majority of the member of the Region 7 Bids and Awards Committee (R07-BAC) recommend to the Head of the Procuring Entity (HoPE) that the procurement of Venue including Accommodation and Meals (AM & PM snacks, complimentary breakfast, buffet lunch, and dinner) for the Trainers and Meals (AM and PM snacks, and buffet lunch) for the Participants during the Central Visayas Regional Statistis Committee Complementary Training on Data Visualization on 24-26 October 2023 be awarded to **One Central Hotel & Suites**.
