**RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (R07-BAC)
 RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THAT THE
 PROCUREMENT OF VENUE WITH ACCOMMODATION AND FOOD (AM & PM SNACKS,
 BUFFET BREAKFAST, BUFFET LUNCH AND BUFFET DINNER) DURING THE SECOND LEVEL
 TRAINING FOR MONTHLY PALAY AND CORN SURVEY AND REPORTING SYSTEM ON 23 TO
 24 JANUARY 2025 BE AWARDED TO GOLDEN PRINCE HOTEL AND SUITES**

Whereas, Philippine Statistics Authority (PSA) - Regional Statistical Services Office 7 needs to procure Venue with Accommodation and Food (AM & PM snacks, buffet breakfast, buffet lunch and buffet dinner) during the Second Level Training for Monthly Palay and Corn Survey and Reporting System on 23 to 24 January 2025;

Whereas, the Purchase Request (PR No.0700-2025-01-004) with an Approved Budget of Contract (ABC) of Twenty-Eight Thousand Seven Hundred Fifty Pesos Only (Php28,750.00) was received by R07-BAC Secretariat on 13 January 2025;

Whereas, this procurement is done through Lease of Venue per approved Indicative Annual Procurement Plan (APP) for CY 2025;

Whereas, the RO-7BAC received quotations from two (2) suppliers namely; 1) Golden Prince Hotel and Suites and 2) Goldberry Suites and Hotel Cebu and two (2) acknowledgement receipts from 1) The Noble Hotel and 2) One Central Hotel and one (1) not available from Deped Ecotech Center a government-owned establishment as stipulated in the abstract of the quotation;

Whereas, during the opening of bids, RO-7 BAC considered the quotation submitted by Golden Prince Hotel and Suites as the Lowest Calculated Quotation (LCQ) is subject for Technical Working Group (TWG) verification on the food menu options to be served during the training;

Whereas, based on the verification in TWG Report No. 2025-01VR-001 dated 17 January 2025 the Technical Working Group of PSA RSSO 7 BAC has confirmed that Golden Prince Hotel and Suites is compliant;

Whereas, on 21 January 2025, the Region 7 and Awards Committee (R07-BAC) conducted another online deliberation through Messenger Group chat;

Whereas, after further evaluation, the R07-BAC declares Golden Prince Hotel and Suites with the Lowest Calculated and Responsive Quotation (LCRQ);

Now, THEREFORE, be it resolved as it is hereby resolved, the members of R07-BAC present during the deliberation unanimously recommend to HOPE that the Procurement of Venue with Accommodation and Food (AM & PM snacks, buffet breakfast, buffet lunch and buffet dinner) during the Second Level Training for Monthly Palay and Corn Survey and Reporting System on 23 to 24 January 2025 be awarded to **Golden Prince Hotel and Suites.**
