- Price quotattion/s must be valid for a period of thirty (30) calendar days from the date of submission. 2 3
- Price quotation/s, to be denominated in Philippine peso, shall include all taxes, duties and/or levies payable. 4
- Quotations exceeding the ABC shall be rejected.
- Award of contract shall be made to the lowest quotation which complies with the technical specifications, and other terms and conditions stated herein.
- 6 Any interlineations, erasures or overwriting shall be valid only if they are signed or initialed by you or your duly authorized representative. 7
- In case of two or more bidders are determined to have submitted the LCRB, the PSA shall adopt and employ "draw lots" as the tie-breaking method to finally detrmine the single winning bidder in accordance with GPPB Circular 06-2005.
- The item/s shall be delivered according to the requirements specified in the Purchase Request (PR). 8 9
- The PSA shall have the right to inspect and/or test the goods to confirm their conformity to the Technical Specifications.
