- Bidders shall provide correct and accurate information required in this form. 1.
- Price quotation/s must be valid for a period of thirty (30) calendar days from the date of submission. 2 Price quotation/s, to be denominated in Philippine peso, shall include all taxes, duties, and/or levies payable.
- 3.
- Quotations exceeding the Approved Budget for the Contract shall be rejected. Award of contract shall be made to the lowest quotation which complies with the technical specifications, and 4. 5 other terms and conditions stated herein.
- Any interlineations, erasures, or overwriting shall be valid only if they are signed or initialed by you or any of your 6 duly authorized representative/s.
- In case of two or more bidders are determined to have submitted the Lowest Calculated Quotation/Lowest 7. Calculated and Responsive Quotation, the PSA shall adopt and employ "draw lots" as the tie-breaking method to finally determine the single winning provider in accordance with GPPB Circular 06-2005.
- The item/s shall be delivered according to the requirements specified in the Technical Specifications.
- 8 The PSA shall have the right to inspect and/or to test the goods to confirm their conformity to the technical 9. specifications.
