4 Quotations exceeding the ABC shall be rejected.			iu/or levies payable.
5	Award of contract shall be made to the lowest quotation which complies with the technical specifications, and other terms and conditions stated herein. This procurement project is to be awarded by lot.		
6 Any interlineations, erasures or overwriting shall be valid only if they are signed or init		ed by you or your duly authorized representative.
