RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (R07-BAC) RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) FOR THE PROCUREMENT OF AIR CONDITIONING PREVENTIVE MAINTENANCE OF PSA-RSSO7 FOR THE YEAR 2025 OF BE AWARDED TO MAXIMAX SYSTEMS, INC.

Whereas, the Philippine Statistics Authority (PSA)-Regional Statistical Services Office 7 needs to procure air conditioning preventive maintenance of PSA RSSO7 for the year 2025;

Whereas, the Purchase Request (PR No. 0700-2025-01-0005) with an Approved Budget of the Contract (ABC) of Sixty- Five Thousand Three Hundred Sixteen Pesos Only (Php65,316.00) was received by R07-BAC Secretariat on 08 January 2025;

Whereas, as approved by HOPE through RO7-BAC Resolution No. 0700-2025-01-R009 dated 15 January 2025, this procurement was done through Small Value Procurement;

Whereas, this procurement was posted on 16 January 2025 at the Philippine Government Electronic Procurement System (PhilGEPS) website with reference no.11669219, Philippine Statistics Authority (PSA) website, and in at least one (1) conspicuous place;

Whereas, RO7-BAC received quotations from two (2) qualified suppliers, namely: 1) Maximax Systems Inc. and 2.) Arm Ventures and Technical Service;

Whereas, the Regional Office 7 Bids and Awards Committee (RO 7 BAC) with the presence of the members of the Technical Working Group (TWG) conducted a deliberation on 22 January 2025 at PSA RSSO VII;

Whereas, during the opening of bids, the R07-BAC considered the quotation submitted by Maximax Systems, Inc. as the Lowest Calculated Quotation (LCQ) subject for TWG verification as to compliance on the required documentary requirement specifically on the submission of the Omnibus Sworn Statement;

Whereas, a verification was conducted through phone call and the result was presented by the TWG to the RO7 BAC on 7 February 2025 per TWG Evaluation Report marked as "Annex A" and forms the integral part hereof;

Whereas, after evaluation, the R07-BAC declares Maximax Systems, Inc. with the Lowest Calculated and Responsive Quotation (LCRQ);
