*Whereas, Philippine Statistics Authority (PSA) - Regional Statistical Services Office 7 is in need to procure of Venue including Accommodation and Food (AM & PM snacks, breakfast, lunch and dinner) during the CRASD 2023 Year-End Performance Review/2024 CRASD Planning Workshop on 06 -08 December 2023;*

*Whereas, an approved Purchase Request with PR No.0700-2023-10-089 was received by the R07-BAC Secretariat;*

*Whereas, the Approved Budget for the Contract (ABC) for the said procurement is **ONE HUNDRED THIRTY -SEVEN THOUSAND EIGHT HUNDRED PESOS ONLY (Php137,800.00)**;*

*Whereas, this procurement was done through Alternative Method of procurement-Lease of Venue;*

*Whereas, the Region 7 Bids and Awards Committee (R07-BAC) received six (6) qualified bid forms from registered establishment namely:1.)Mist Mountain Resort,2.)Pumpbeach Resort and SPA,3.)Serenity Farm Resort(SFAR)4.) Alta Cebu Village Garden Resort.5.) Dep-ed Ecotech Center and 6.)Cebu Westown Lagoon;*

*Whereas, the Region 7 Bids and Awards Committee (R07-BAC) with the presence of the member of the Technical Working Group (TWG) conducted a deliberation on 22 November 2023;*

*Whereas, during the opening of bids, R07-BAC declared submitted by Alta Cebu Village Garden Resort Inc.as the Lowest Calculated Quotation (LCQ) subject for verification on the safety and quality of the area (presence of mosquito and water pressure);*

*Whereas, a verification was conducted and the result was presented by the TWG to the R07-BAC on 27 November 2023 that Alta Cebu Village Garden Resort Inc. is responsive and can comply on the laid technical specification of the procurement;*
