SUBJECT : Reproduction of the 2022 Census of Agriculture and Fisheries (2022 CAF) Form 11 - Notice of Listing/Enumeration (Sticker) for Household Interviews

DATE : 20 September 2023

In connection with the conduct of the 2022 Census of Agriculture and Fisheries (2022 CAF) household and barangay interviews, there was an instruction that only households with at least one agricultural, aquaculture, and/or fishing operator must have a sticker posted in a conspicuous part of the building/housing unit. Further, it is advised that the sticker be posted in front of the house or on the gate of the building after the listing/enumeration.

Due to the increase in number of individuals/households engaged in urban farming and other emerging crop practices/activities, the number of households with at least one operator have most likely increased. The cut-off criteria to identify operators, particularly on crop farming was likewise done away with. These could have been some of the reasons for the reported shortage of CAF Form 11 in many provinces. In view of this, all Regional Statistical Services Offices (RSSOs) and/or Provincial Statistical Offices (PSOs) are instructed to reproduce the CAF Form 11, depending on the quantity needed per province, to ensure that all buildings/housing units of households with at least one operator are marked with a sticker.

The specifications of the CAF Form 11 are as follows: (a) 3-1/2" x 4-1/2", one side; (b) opaque polyester or similar water and heat resistant material; (c) resistive non-shifting material, 90 GSM; (d) high-quality, general purpose, industrial grade, clear adhesive; (e) 4 colors, loose 300 pieces/pack. All expenses to be incurred in this activity shall be charged to your savings, generated from the procurement of supplies and materials for the CAF. If the savings will be insufficient, we shall provide you with additional funds through the Fund Transfer that will be effected in October 2023.
