RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THAT THE
PROCUREMENT OF VENUE INCLUDING ACCOMMODATION WITH MEALS DURING THE
CONDUCT OF THE 2022 ANNUAL SURVEY OF PHILIPPINE BUSINESS AND INDUSTRY
(ASPBI) REGIONAL DATA DISSEMINATION & 2024 QUARTERLY SURVEY OF PHILIPPINE
BUSINESS AND INDUSTRY (QSPBI) REGIONAL RESPONDENTS' FORUM BRIEFING ON 29
NOVEMBER 2024 BE SUBJECT TO TWG VERIFICATION

Whereas, Philippine Statistics Authority (PSA) - Regional Statistical Services Office 7 needs to procure of Venue including Accommodation with Meals during the conduct of the 2022 Annual Survey of Philippine Business and Industry (ASPBI) Regional Data Dissemination & 2024 Quarterly Survey of Philippine Business and Industry (QSPBI) Regional Respondents' Forum Briefing on 29 November 2024;

Whereas, the Purchase Request (PR No.0700-2024-11-088) with an Approved Budget of Contract (ABC) of One Hundred Forty Thousand Three Hundred Twenty Pesos Only (Php140,320.00) was received by R07-BAC Secretariat on 18 November 2024;

Whereas, as approved by HOPE thru ROBAC Resolution No.0700-2024-11-R878 dated 19 November 2024, this procurement was done through Lease of Venue;

Whereas, RO-7BAC received quotations from four (4) suppliers namely; 1.) Eastland Hotel & Residences, 2.) William Entertainment and Food OPC/ ICONIQUE, 3.) Duros Hotels Inc., and 4.) Diamond Suites and Residences and two (2) acknowledgement receipts from 1.) The Noble Hotel and 2.) One Central Hotel and one (1) not available from Deped Ecotech Center a government-owned establishment as stipulated in the abstract of the quotation;

Whereas, during the opening of bids, RO-7 BAC considered the quotation submitted by Eastland Hotel & Residences as the Lowest Calculated Quotation (LCQ), subject for Technical Working Group (TWG) verification as a first-time supplier of PSA Region 7 Office in 2024, including the venue being offered and the supporting documentary requirements;

Now, THEREFORE, be it resolved as it is hereby resolved, the members of R07-BAC present during the deliberation unanimously recommend to HOPE that the Procurement of Venue including Accommodation with Meals during the conduct of the 2022 Annual Survey of Philippine Business and Industry (ASPBI) Regional Data Dissemination & 2024 Quarterly Survey of Philippine Business and Industry (QSPBI) Regional Respondents' Forum Briefing on 29 November 2024 be subjected to TWG verification.
