**2025 BE AWARDED TO GOLDEN PRINCE HOTEL AND SUITES**

*Whereas, Philippine Statistics Authority (PSA) - Regional Statistical Services Office 7 needs to procure of Venue with accommodation and food (AM & PM snacks, buffet breakfast, buffet lunch and buffet dinner) during conduct of the Second Level Training on the 2025 Commodity Flow Survey on 25 to 27 March 2025;*

*Whereas, the Purchase Request (**PR No.0700-2025-03-024**) with an Approved Budget of Contract (ABC) of One Hundred Thousand Five Hundred Pesos Only (Php100,500.00) was received by the Regional Office 7 Bids and Awards Committee (R07-BAC) on 15 March 2025;*

*Whereas, as approved by the Head of the Procuring Entity (HOPE) through R07-BAC Resolution No. 0700-2025-02-R047A dated 05 February 2025, this procurement was done through Lease of Venue;*

*Whereas, R07-BAC received quotations from three (3) suppliers: 1) Duros Hotel, Inc., 2) Summit Galleria, and 3) Cebu Business Hotel and two (2) suppliers acknowledged receipt of the request namely: 1) Noble Hotel and 2) Radisson Blue Hotel and one (1) not available from Deped Ecotech Center, a government-owned establishment, as stipulated in the abstract of quotation;*

*Whereas, during the opening of bids, the R07-BAC considered the quotation submitted by Cebu Business Hotel as the Lowest Calculated Quotation (LCQ);*

*Whereas, after further bid evaluation, the R07-BAC declares Cebu Business Hotel with the Lowest Calculated and Responsive Quotation (LCRQ);*

**Now, THEREFORE,** be it resolved as it is hereby resolved that the members of Regional Office 7 Bids and Awards Committee (R07-BAC) present during the deliberation unanimously recommend to the Head of the Procuring Entity (HOPE) that the Procurement of Venue with accommodation and food (AM & PM snacks, buffet breakfast, buffet lunch and buffet dinner) during conduct of the Second Level Training on the 2025 Commodity Flow Survey on 25 March to 27 March 2025 be awarded to **Cebu Business Hotel**.
