Whereas, Philippine Statistics Authority (PSA) - Regional Statistical Services Office 7 needs to procure of Venue with accommodation and food (AM & PM snacks, buffet breakfast, buffet lunch and buffet dinner) during conduct of the Second Level Training on the 2025 Commodity Flow Survey on 25 to 27 March 2025;

Whereas, the Purchase Request (<u>PR No.0700-2025-03-024)</u> with an Approved Budget of Contract (ABC) of One Hundred Thousand Five Hundred Pesos Only (Php100,500.00) was received by the Regional Office 7 Bids and Awards Committee (R07-BAC) on 15 March 2025;

Whereas, as approved by the Head of the Procuring Entity (HOPE) through RO7-BAC Resolution No. 0700-2025-02-R047A dated 05 February 2025, this procurement was done through Lease of Venue;

Whereas, RO7-BAC received quotations from three (3) suppliers: 1) Duros Hotel, Inc., 2) Summit Galleria, and 3) Cebu Business Hotel and two (2) suppliers acknowledged receipt of the request namely: 1) Noble Hotel and 2) Radisson Blue Hotel and one (1) not available from Deped Ecotech Center, a government-owned establishment, as stipulated in the abstract of quotation;

Whereas, during the opening of bids, the RO7-BAC considered the quotation submitted by Cebu Business Hotel as the Lowest Calculated Quotation (LCQ);

Whereas, after further bid evaluation, the RO7-BAC declares Cebu Business Hotel with the Lowest Calculated and Responsive Quotation (LCRQ);

Now, THEREFORE, be it resolved as it is hereby resolved that the members of Regional Office 7 Bids and Awards Committee (R07-BAC) present during the deliberation unanimously recommend to the Head of the Procuring Entity (HOPE) that the Procurement of Venue with accommodation and food (AM & PM snacks, buffet breakfast, buffet lunch and buffet dinner) during conduct of the Second Level Training on the 2025 Commodity Flow Survey on 25 March to 27 March 2025 be awarded to Cebu Business Hotel.
