**RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (R07-BAC)**  
**RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THAT THE**  
**PROCUREMENT OF BALLOONS FOR THE CONDUCT OF THE REGIONAL DATA FESTIVAL**  
**FOR VISAYAS CLUSTER BE AWARDED TO L.G COPY EXPRESS**

**Whereas**, Philippine Statistics Authority (PSA) - Regional Statistical Services Office 7 needs to procure Balloons for the conduct of the Regional Data Festival for Visayas Cluster;

**Whereas**, the Purchase Request (PR No.0700-2024-09-067A) with an Approved Budget of Contract (ABC) Four Thousand Two Hundred Pesos Only (Php4,200.00) was received by R07-BAC Secretariat on 08 October 2024;

**Whereas**, as approved by HOPE thru ROBAC Resolution No.0700-2024-10-R759 dated 09 October 2024, this procurement was done through Small Value Procurement;

**Whereas**, this procurement was posted on 12 October 2024 at the Philippine Government Electronic Procurement System (PhilGEPS) website with reference no.11354724, Philippine Statistics Authority (PSA) website, and in at least one (1) conspicuous place;

**Whereas**, RO-7BAC received quotations from two (2) suppliers namely 1.) Arteestic Printshoppe and 2.) L.G Copy Express, as stipulated in the abstract of the quotation;

**Whereas**, during the opening of bids, it was noted that quotations submitted by Arteestic Printshoppe and L.G Copy Express offered the same quotation;

**Whereas**, R07-BAC declared for a toss coin between Arteestic Printshoppe and L.G Copy Express, with L.G Copy Express assigned as tails and Arteestic Printshoppe as heads, as a tie-breaking method to determine the winning bidder;

**Whereas**, the result of the toss coin was tails, which favored to L.G Copy Express;

**Whereas**, after further bid evaluation, the RO-7 BAC declares L.G Copy Express with the Lowest Calculated and Responsive Quotation (LCRQ), having complied with all technical specifications;

**Now, THEREFORE**, be it resolved as it is hereby resolved, the members of R07-BAC present during the deliberation unanimously recommend to HOPE that the Procurement of Balloons for the conduct of the Regional Data Festival for Visayas Cluster be awarded to **L.G Copy Express**.
