**RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (R07-BAC)
RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THAT THE
PROCUREMENT OF CERTIFICATE HOLDER WITH PRINTED PSA LOGO FOR THE 35th
NATIONAL STATISTICS MONTH BE AWARDED TO ARTEESTIC PRINTSHOPPE**

Whereas, Philippine Statistics Authority (PSA) - Regional Statistical Services Office 7 needs to procure Certificate Holder with printed PSA Logo for the 35th National Statistics Month;

Whereas, the Purchase Request (**PR No.0700-2024-09-067A**) with an Approved Budget of Contract (ABC) **Fifteen Thousand Pesos Only (Php 15,000.00)** was received by R07-BAC Secretariat on 30 September 2024;

Whereas, as approved by HOPE thru ROBAC Resolution No.0700-2024-09-R733 dated 04 October 2024, this procurement was done through Small Value Procurement;

Whereas, this procurement was posted on 08 October 2024 at the Philippine Government Electronic Procurement System (PhilGEPS) website with reference no.11330146, Philippine Statistics Authority (PSA) website, and in at least one (1) conspicuous place;

Whereas, RO-7BAC received quotations from two (2) suppliers namely; **1.) Arteestic Printshoppe and 2.) Awards Central Philippines Inc.** as stipulated in the abstract of the quotation;

Whereas, during the opening of bids, RO-7 BAC considered the quotation submitted by **Arteestic Printshoppe** as the Lowest Calculated Quotation (LCQ);

Whereas, after further bid evaluation, the RO-7 BAC declares **Arteestic Printshoppe** with the Lowest Calculated and Responsive Quotation (LCRQ);

Now, THEREFORE, be it resolved as it is hereby resolved, the members of R07-BAC present during the deliberation unanimously recommend to HOPE that the Procurement of Certificate Holder with printed PSA Logo for the 35th National Statistics Month be awarded to **Arteestic Printshoppe**.
