RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (R07-BAC)
RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THAT THE
PROCUREMENT OF TOKEN FOR THE SPEAKERS DURING THE CONDUCT OF THE 2023 FULL
YEAR POVERTY STATISTICS REGIONAL DISSEMINATION FORUM-CENTRAL VISAYAS ON 25
OCTOBER 2024 BE AWARDED TO ARTEESTIC PRINTSHOPPE

Whereas, Philippine Statistics Authority (PSA) - Regional Statistical Services Office 7 needs to procure Token for the Speakers during the Conduct of the 2023 Full Year Poverty Statistics Regional Dissemination Forum-Central Visayas on 25 October 2024;

*Whereas, the Purchase Request (**PR No.0700-2024-10-068**) with an Approved Budget of Contract (ABC) of **Five Thousand Pesos Only (Php5,000.00)** was received by R07-BAC Secretariat on 01 October 2024;*

Whereas, as approved by HOPE thru ROBAC Resolution No.0700-2024-10-R762 dated 09 October 2024, this procurement was done through Small Value Procurement;

Whereas, this procurement was posted on 19 October 2024 at the Philippine Government Electronic Procurement System (PhilGEPS) website with reference no.11382756, Philippine Statistics Authority (PSA) website, and in at least one (1) conspicuous place;

Whereas, RO-7BAC received quotation from one (1) supplier namely; 1.) Arteestic Printshoppe and three (3) acknowledgement receipts from 1.) Awards Central Philippines, Inc., 2.) Ai-ren Design Ads, and 3.) Stiches N' Wear Industries as stipulated in the abstract of the quotation;

*Whereas, during the opening of bids, RO-7 BAC considered the quotation submitted by **Arteestic Printshoppe** as the Lowest Calculated Quotation (LCQ);*

*Whereas, after further bid evaluation, the RO-7 BAC declares **Arteestic Printshoppe** with the Lowest Calculated and Responsive Quotation (LCRQ);*

***Now, THEREFORE,** be it resolved as it is hereby resolved, the members of R07-BAC present during the deliberation unanimously recommend to HOPE that the Procurement of Token for the Speakers during the Conduct of the 2023 Full Year Poverty Statistics Regional Dissemination Forum-Central Visayas on 25 October 2024 be awarded to **Arteestic Printshoppe**.*
