Whereas, Philippine Statistics Authority (PSA) - Regional Statistical Services Office 7 needs to procure Venue including Accommodation and Meals (Am and Pm Snacks, Complimentary Breakfast, Buffet Lunch, And Dinner) for the Trainers and Meals (Am and Pm Snack, And Buffet Lunch) for the participants during the Central Visayas Regional Statistics Committee Complementary Training on Mastering Data Management: A Guide to Google Sheets and MS Excel on 17-19 September 2024;

Whereas, the Purchase Request (<u>PR No.0700-2024-08-050</u>) with an Approved Budget of Contract (ABC) of One Hundred Sixty-Three Thousand Three Hundred Fifty Pesos Only (Php163,350.00) was received by R07-BAC Secretariat on 16 August 2024.

Whereas, as approved by HOPE thru ROBAC Resolution No.0700-2024-08-R606 dated 28 August 2024, this procurement was done through Lease of Venue;

Whereas, (RO-7BAC) received quotations from two (2) qualified suppliers namely; 1) One Central Hotel and 2) Golden Prince Hotel and Suites and one (1) acknowledgement receipt from The Noble Hotel and one (1) not available from Deped Ecotech Center a government-owned establishment as stipulated in the abstract of the quotation;

Whereas, during the opening of bids, RO-7 BAC considered the quotation submitted by One Central Hotel as the Lowest Calculated Quotation (LCQ) was subjected for TWG verification as a first-time supplier of PSA Region 7 Office in 2024, including internet connection speed and the venue offered:

Whereas, based on the verification with TWG Report No. 2024-09VR-019 dated 06 August 2024 the Technical Working Group of PSA RSSO 7 BAC have ascertained that One Central Hotel is compliant on the laid technical and documentary requirements of the procurement;

Whereas, on 11 September 2024, the Region 7 and Awards Committee (R07-BAC) conducted an online deliberation through Google Meet;

Whereas, after further evaluation, the R07-BAC declares One Central Hotel with the Lowest Calculated and Responsive Quotation (LCRQ);

Now, THEREFORE, be it resolved as it is hereby resolved, the members of R07-BAC present during the deliberation unanimously recommend to HOPE that the Procurement of Venue including Accommodation and Meals (Am and Pm Snacks, Complimentary Breakfast, Buffet Lunch, And Dinner) for the Trainers and Meals (Am and Pm Snack, And Buffet Lunch) for the participants during the Central Visayas Regional Statistics Committee Complementary Training on Mastering Data Management: A Guide to Google Sheets and MS Excel on 17-19 September 2024 be awarded to One Central Hotel.
