RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (R07-BAC) RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THAT THE PROCUREMENT OF CUSTOMIZED POLO SHIRT FOR THE 2023 GEO-ENABLED MASTER SAMPLE REGIONAL DATA DISSEMINATION FORUM ON 30 MAY 2023 BE AWARDED TO ARTEESTIC PRINTSHOPPE

WHEREAS, the Philippine Statistics Authority (PSA)-Regional Statistical Services Office 7 needs to procure Customized Polo Shirt for the 2023 Geo-enabled Master Sample Regional Data Dissemination Forum on 30 May 2023;

*WHEREAS, an approved Purchase Request with **PR No. 0700-2023-05-038** was received by the R07-BAC Secretariat;*

WHEREAS, this procurement was done by lot;

WHEREAS, this procurement was posted on the Philippine Government Electronic Procurement System (PhilGEPS) website, Philippine Statistics Authority (PSA) website, in compliance with the 2016 IRR of RA 9184 on 20 May 2023 with reference no. 9771269;

*WHEREAS, the Approved Budget for the Contract (ABC) for the said procurement is **EIGHTY THOUSAND FIVE HUNDRED PESOS ONLY (80,500.00)**;*

WHEREAS, the Request for Quotation (RFQ) was sent to various suppliers which are registered with PhilGEPS;

*WHEREAS, before the closing date of the submission, the secretariat received six (6) qualified quotations namely: 1.) **Arteestic Printshoppe**, 2.) **JCE Marketing**, 3.) **Anduillier Int'l Sales Corp.**, 4.) **Stitches 'N Wear & Industries**, 5.) **Panalay Tailoring**, and 6.) **IGP Printing Services** as stipulated in the abstract of the quotation;*

*WHEREAS the Region 7 Bids and Awards Committee (R07-BAC) with the presence of a member of the Technical Working Group (TWG) conducted a deliberation on **24 May 2023** at PSA RSSO 7 Conference;*

*WHEREAS during the deliberation, the Region 7 Bids and Awards Committee (R07-BAC) considered the quotation submitted by **Arteestic Printshoppe and Anduillier Int'l Sales Corp.** as the Lowest calculated quotation (LCQ) for having the same amount of quotation;*
