RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (R07-BAC) RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THAT THE PROCUREMENT OF PROCUREMENT OF VENUE WITH ACCOMMODATION AND FOOD DURING THE WRITESHOP ON THE PREPARATION OF IEC MATERIALS FOR PPA DISSEMINATION FOR A BE AWARDED TO GOLDBERRY SUITES AND HOTEL

WHEREAS, Philippine Statistics Authority (PSA) - Regional Statistical Services Office 7 needs to procure Procurement of venue with Accommodation and Food (AM & PM snacks, buffet breakfast, buffet lunch and buffet dinner) during the Writeshop on the Preparation of IEC Materials for PPA Dissemination Fora on 13-17 November 2023;

WHEREAS an approved Purchase Request with **PR No. 0700-2023-11-100** was received by the R07-BAC secretariat;

WHEREAS, the Approved Budget for the Contract (ABC) for the said procurement is **ONE HUNDRED SEVENTEEN THOUSAND SEVEN HUNDRED PESOS ONLY** (PhP117,700.00);

WHEREAS, Alternative Method of Procurement – Lease of Venue was used for the said procurement;

WHEREAS, this procurement was not posted on the Philippine Government Electronic Procurement System (PhilGEPS) website and Philippine Statistics Authority (PSA) website;

WHEREAS, Request for Quotations (RFQs)/Bid Forms was sent to various PhilGEPS registered establishments;

WHEREAS, the Region 7 Bids and Awards Committee (R07-BAC) received two (2) qualified quotations from 1.) Goldberry Suites and Hotel 2.) Harolds Evotel and three (3) acknowledgments from 1.) Azia Suites and Residences 2.) Golden Peak Hotel and 3.) Bai Hotel as enumerated in the abstract of quotation;

WHEREAS, the Region 7 Bids and Awards Committee (R07-BAC) with the presence of the members of the Technical Working Group (TWG) conducted an online deliberation via Messenger on 11 November 2023;

WHEREAS, during the deliberation, the Region 7 Bids and Awards (R07-BAC) considered the quotation submitted by Goldberry Suites and Hotel as the Lowest Calculated Quotation (LCQ);

WHEREAS, after thorough evaluation, the R07-BAC declared the quotation submitted by Goldberry Suites and Hotel as the Lowest Calculated and Responsive Quotation (LCRQ);


Now, THEREFORE, be it resolved as it is hereby resolved that the members of the Region 7 Bids and Awards Committee (R07-BAC) present during the deliberation unanimously recommend to the Head of the Procuring Entity (HoPE) that the procurement of Accommodation and Food (AM & PM snacks, buffet breakfast, buffet lunch and buffet dinner) during the Writeshop on the Preparation of IEC Materials for PPA Dissemination Fora on 13-17 November 2023 be awarded to Goldberry Suites and Hotel.
