**RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (R07-BAC)  
 RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THAT THE  
 PROCUREMENT OF VENUE WITH FOOD (AM & PM SNACKS WITH BUFFET MEALS  
 (LUNCH AND DINNER) DURING THE SOCD GROUP LEARNING SESSION ON 27-28  
 JANUARY 2025: REVIEW AND EVALUATION OF STATISTICAL OPERATIONS  
 BE AWARDED TO GOLDEN PRINCE HOTEL AND SUITES**

*Whereas, Philippine Statistics Authority (PSA) - Regional Statistical Services Office 7 needs to procure Venue with Food (AM & PM snacks with buffet meals (lunch and dinner) during the SOCD Group Learning Session on 27-28 January 2025: Review and Evaluation of Statistical Operations;*

*Whereas, the Purchase Request (**PR No.0700-2025-01-008**) with an Approved Budget of Contract (ABC) of Fifty Thousand Four Hundred Pesos Only (Php50,400.00) was received by R07-BAC Secretariat on 22 January 2025;*

*Whereas, as approved by HOPE thru ROBAC Resolution No.0700-2025-01-R016 dated 22 January 2025, this procurement was done through Lease of Venue;*

*Whereas, the RO-7BAC received quotations from four (4) suppliers namely; 1) Golden Prince Hotel and Suites, 2) Cebu Business Hotel, 3) William Entertainment & Food OPC, and 4) One Central Hotel and one (1) not available from Deped Ecotech Center a government-owned establishment as stipulated in the abstract of the quotation;*

*Whereas, during the opening of bids, RO-7 BAC considered the quotation submitted by Golden Prince Hotel and Suites as the Lowest Calculated Quotation (LCQ) is subject for Technical Working Group (TWG) verification on the food menu options to be served during the training;*

*Whereas, based on the verification in TWG Report No. 2025-01VR-002 dated 24 January 2025 the Technical Working Group of PSA RSSO 7 BAC has confirmed that Golden Prince Hotel and Suites is compliant;*

*Whereas, on 24 January 2025, the Region 7 and Awards Committee (R07-BAC) conducted another face-to-face deliberation;*

*Whereas, after further evaluation, the R07-BAC declares Golden Prince Hotel and Suites with the Lowest Calculated and Responsive Quotation (LCRQ);*

**Now, THEREFORE, be it resolved as it is hereby resolved, the members of R07-BAC present during the deliberation unanimously recommend to HOPE that the Procurement of Venue with Food (AM & PM snacks with buffet meals (lunch and dinner) during the SOCD Group Learning Session on 27-28 January 2025: Review and Evaluation of Statistical Operations be awarded to **Golden Prince Hotel and Suites.****
