**RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (R07-BAC)
RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THAT THE
PROCUREMENT OF TARPAULIN PRINTING FOR THE 35th NATIONAL STATISTICS MONTH BE
AWARDED TO L.G COPY EXPRESS**

Whereas, Philippine Statistics Authority (PSA) - Regional Statistical Services Office 7 needs to procure Tarpaulin Printing for the 35th National Statistics Month;

Whereas, the Purchase Request (PR No.0700-2024-09-067A) with an Approved Budget of Contract (ABC) Two Thousand Five Hundred Eighty Pesos Only (Php 2,580.00) was received by R07-BAC Secretariat on 30 September 2024;

Whereas, as approved by HOPE thru ROBAC Resolution No.0700-2024-09-R731 dated 04 October 2024, this procurement was done through Small Value Procurement;

Whereas, this procurement was posted on 08 October 2024 at the Philippine Government Electronic Procurement System (PhilGEPS) website with reference no.11329449, Philippine Statistics Authority (PSA) website, and in at least one (1) conspicuous place;

Whereas, RO-7BAC received quotations from four (4) suppliers namely; 1.) Arteestic Printshoppe, 2.) L.G Copy Express, 3.) DMC Busa Printshoppe, and 4.) BQE Office and Supplies Trading as stipulated in the abstract of the quotation;

Whereas, during the deliberation, it was noted that quotations submitted by the four (4) suppliers offered the same price quotation; however, the quotations from DMC Busa Printshoppe and BQE Office and Supplies Trading did not include the amount written in words;

Whereas, RO 7 BAC proceeded the deliberation to the remaining bidders, Arteestic Printshoppe and L.G Copy Express, and both were considered as the Lowest Calculated Quotations (LCQ) which offered same price quotation;

Whereas, R07-BAC declared for a toss coin between Arteestic Printshoppe and L.G Copy Express, with L.G Copy Express assigned as tails and Arteestic Printshoppe as heads as a tie-breaking method to determine the winning bidder;

Whereas, the result of the toss coin was tails, which favored to L.G Copy Express;

Whereas, after further bid evaluation, the RO-7 BAC declares L.G Copy Express with the Lowest Calculated and Responsive Quotation (LCRQ), having complied with all technical specifications;


Now, THEREFORE, be it resolved as it is hereby resolved, the members of R07-BAC present during the deliberation unanimously recommend to HOPE that the Procurement of Tarpaulin Printing for the 35th National Statistics Month be awarded to **L.G Copy Express**.
