Whereas, during the opening of bids, RO-7 BAC considered the quotation submitted by Artteestic Printshoppe as the Lowest Calculated Quotation (LCQ);

Whereas, after further bid evaluation, the RO-7 BAC declares Artteestic Printshoppe with the Lowest Calculated and Responsive Quotation (LCRQ);

Now, THEREFORE, be it resolved as it is hereby resolved, the members of R07-BAC present during the deliberation unanimously recommend to HOPE that the Procurement of Token for Sample Establishments for the 3rd Quarter 2024 Commodity Flow Survey be awarded to **Artteestic Printshoppe**.
