Noted. The Audited Financial Statement should be for the year 2014.
BB1-02	Section VI page 68	Requested that delivery period is within 60 days from the effective date stated in the Notice to Proceed. There is no possible supplier that could meet the 30 calendar days. With 60 days they have to produce at least 2,030/day to meet the deadline.	The Chairperson clarified that partial delivery up to 45 days will be considered. However, all the items should be delivered before the start of the 1st Level Training. Please refer to Annex C of the Bid Documents for prioritization of the delivery schedule.
BB1-03	Financial Documents for Eligibility Check page 94	Clarification on the Net Financial Contracting Capacity (NFCC) whether per lot or the sum of all the lots.	The NFCC is per lot. If the bidder will bid for all the lots then the NFCC will be the sum for all the lots.
BB1-04	Technical Specifications page 72	Design of the sample bag is different from the pictures shown in Attachment D. The actual size also varies from what is stated in the Technical specifications. For the umbrella, it was suggested to delete the coat of arms.	Will provide the actual design. See attached. Noted. The coat of arms in the umbrella will be deleted.
BB1-05		One of the bidders requested that bidders should bring/submit samples during the Opening of Bids.	Interested bidders should submit samples, upon submission of bids.
