RESOLUTION OF PHILIPPINE STATISTICS AUTHORITY REGION 7 BIDS AND AWARDS COMMITTEE (PSA R07-BAC) FOR THE ISSUANCE OF AWARD FOR PROCUREMENT AND DELIVERY OF SUPPLIES AND MATERIALS FOR THE 2024 CENSUS OF POPULATION AND COMMUNITY-BASED MONITORING SYSTEM (2024 POPCEN-CBMS) HOUSEHOLD PROFILE QUESTIONNAIRE DATA COLLECTION

Whereas, the Philippine Statistics Authority Regional Statistical Services Office No. 7 and the Provincial Offices of Bohol, Cebu, Negros Oriental, and Siquijor needs to procure Supplies and Materials for the 2024 Census of Population and Community-Based Monitoring System (2024 POPCEN-CBMS) Household Profile Questionnaire Data Collection.

Whereas, this procurement was done through Competitive Bidding with THIRTEEN MILLION FOUR HUNDRED TWENTY THOUSAND SIX HUNDRED SIXTY-SEVEN PESOS AND THIRTY-SIX CENTAVOS ONLY (PHP13,420,667.36) as the total Approved Budget for the Contract (ABC) with a corresponding ABC per lot as follows;

Whereas, the BAC checked all submitted documents of each bidder for the first component envelope (Technical Component) against the checklist of required documents to ascertain if they are all present, using a non-discretionary "pass or fail" criterion;

Whereas, the bid submitted by Mitsui Trading Philippines, Avecilla Trading, MGC General Enterprises and Knit and Tuck Merchandising for the requirements under the first component envelope (Technical Component) were complete and patently sufficient;

Whereas, Mitsui Trading Philippines, Avecilla Trading, MGC General Enterprises and Knit and Tuck Merchandising were rated "pass" and were declared as technically complying bidders after the opening of the first component envelope (Technical Component);

Whereas, the second component envelope (Financial Component) of all technically complying bidders were immediately opened;
