RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (R07-BAC) RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THAT THE PROCUREMENT OF VENUE AND ACCOMMODATION WITH BREAKFAST FOR THE 2024 POPCEN-CBMS BRIEFING, DISTRIBUTION OF MATERIALS, EDITING, CODING FOR THE RESCUERS/ ENUMERATORS FROM OTHER REGIONS/ PROVINCES TO AUGMENT THE MANPOWER OF HIGHLY URBANIZED CITIES OF CITY OF CEBU, AND CITY OF MANDAUE BE AWARDED TO CEBU BUSINESS HOTEL.

Whereas, Philippine Statistics Authority (PSA) - Regional Statistical Services Office 7 needs to procure Venue and accommodation with breakfast for the 2024 POPCEN-CBMS briefing, distribution of materials, editing, coding for the Rescuers/ Enumerators from other regions/ Provinces to augment the manpower of Highly Urbanized Cities of City of Cebu, and City of Mandaue;

*Whereas, the Purchase Request (**PR No. 0722-2024-11-147**) with an Approved Budget of Contract (ABC) Two Hundred Fifty-Two Thousand Pesos Only (Php 252,000.00) was received by R07-BAC Secretariat on 07 December 2024;*

Whereas, as approved by HOPE thru ROBAC Resolution No. 0700-2024-12-R947E dated 07 December 2024, this procurement was done through Lease of Venue.


WHEREAS, (RO-7BAC) received quotations from four (4) qualified suppliers namely; 1) Cebu Business Hotel, 2.) Golden Peak Hotel and Suites, 3.) Golden Prince Hotel and Suites and 4.) Deped Ecotech Center-government owned establishment which was not available, two (2) establishments have submitted a responsive, and 1 of which have received only the quotations as stipulated in the abstract of the quotation.

*Whereas, on 10 December 2024, the RO7-BAC conducted a special deliberation via Messenger through the Official Group Chat of the RO7-BAC and considered the quotation submitted by **Cebu Business Hotel** as the Lowest Calculated Quotation (LCQ).*


*Whereas, upon careful evaluation, the Region 7 Bids and Awards Committee (R07-BAC) considered the quotation submitted by **Cebu Business Hotel** as the Lowest Calculated and Responsive Quotation (LCRQ).*

Now, THEREFORE, be it resolved as it is hereby resolved, the members of R07-BAC present during the deliberation unanimously recommend to HOPE that the Procurement of Venue and accommodation with breakfast for the 2024 POPCEN-CBMS briefing, distribution of materials, editing, coding for the Rescuers/ Enumerators from other regions/ Provinces to augment the manpower of Highly Urbanized Cities of City of Cebu, and City of Mandaue be awarded to **Cebu Business Hotel.**


