**RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (R07-BAC) RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THAT THE PROCUREMENT OF VENUE WITH ACCOMODATION AND FOOD FOR THE CONDUCT OF 2024 POPCEN CBMS DATA ANALYSIS, DATA VALIDATION AND ASSESSMENT, FIELD SUPERVISION, VERIFICATION AND SATURATION DRIVE FOR HUC CEBU CITY BE AWARDED TO CEBU BUSINESS HOTEL.**

**Whereas**, the Philippine Statistics Authority- Cebu Provincial Statistical Office (PSA Cebu PSO), Cebu City, Cebu needs to procure Venue with accommodation and food for the conduct of 2024 POPCEN CBMS Data Analysis, Data Validation and Assessment, Field supervision, verification and saturation drive for HUC Cebu City;

**Whereas**, the Purchase Request (**PR No.0722-2024-11-130**) with an Approved Budget of Contract (ABC) Four Hundred Thirteen Thousand Five Hundred Fifty Pesos Only (Php413,500.00) was received by R07-BAC Secretariat on 12 November 2024;

**Whereas**, as approved by HOPE thru ROBAC Resolution No.0700-2024-11-R854A dated 12 November 2024, this procurement was done through Lease of Venue;

**WHEREAS**, (RO-7BAC) received quotations from three (3) qualified suppliers namely; **1) Cebu Business Hotel, 2) Golden Peak Hotel and Suites; (3) Golden Prince Hotel & Suites** and one (1) non-availability from DepEd Ecotech Center a government-owned establishment as stipulated in the abstract of the quotation;

**Whereas**, on **15 November June 2024**, the R07-BAC conducted a deliberation through video teleconferencing and considered the quotation submitted by **Golden Peak Hotel and Suites** as the Lowest Calculated Quotation (LCQ);

**Whereas**, upon evaluation, R07-BAC with the assistance of the Technical Working Group (TWG) declared **Golden Peak Hotel and Suites** as unresponsive service provider as they can't accommodate us on the Item 1.4 as stated in their submitted bid form and moved to consider the next LCQ, **Cebu Business Hotel**;

**Whereas**, upon careful evaluation, post qualification, and verification, R07-BAC with the assistance of the Technical Working Group (TWG) declared **Cebu Business Hotel** with the Lowest Calculated and Responsive Quotation (LCRQ) having complied, responsive and eligible service provider;

**Now, THEREFORE**, be it resolved as it is hereby resolved, the members of R07-BAC present during the deliberation unanimously recommend to HOPE that the Procurement of Venue with accommodation and food for the conduct of 2024 POPCEN CBMS Data Analysis, Data Validation and Assessment, Field supervision, verification and saturation drive for HUC Cebu City be awarded to **Cebu Business Hotel**.
