**RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (R07-BAC)
RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THAT THE
PROCUREMENT OF VENUE INCLUDING ACCOMMODATION AND MEALS DURING THE
CREATIVE INDUSTRIES SATELLITE ACCOUNTS PHASE 2 FOCUS GROUP DISCUSSIONS
(FGDS) ON CREATIVE ECONOMY OF VISAYAS CLUSTER ON 26 NOVEMBER 2024 BE
AWARDED TO GOLDEN PRINCE HOTEL AND SUITES**

Whereas, Philippine Statistics Authority (PSA) - Regional Statistical Services Office 7 needs to procure Venue including accommodation and meals during the Creative Industries Satellite Accounts Phase 2 Focus Group Discussions (FGDS) on Creative Economy of Visayas Cluster on 26 November 2024;

Whereas, the Purchase Request (PR No.0700-2024-11-079) with an Approved Budget of Contract (ABC) of One Hundred Ninety-Five Thousand Pesos Only (Php195,000.00) was received by R07-BAC Secretariat on 11 November 2024;

Whereas, as approved by HOPE thru ROBAC Resolution No.0700-2024-11-R852 dated November 2024, this procurement was done through Lease of Venue;

Whereas, the procurement was declared failure on 20 November 2024 due to the absence of Bids from Suppliers;

Whereas, as per resolution number 0700-2024-11-R886 dated on 20 November 2024, the procurement was recanvassed and the closing date was on 22 November 2024 at 03:00 PM;

Whereas, RO-7BAC received quotations from two (2) suppliers namely; 1.) Golden Prince Hotel and Suites and 2) Duros Hotels Inc, and three (3) acknowledgement receipts from 1.) The Noble Hotel, 2.) Diamond Suites and Residences, 3) One Central Hotel and one (1) not available from Deped Ecotech Center a government-owned establishment as stipulated in the abstract of the quotation;

Whereas, during opening of bids, RO 7 BAC considered the bids submitted by Golden Prince Hotel and Suites as LCQ as per Abstract of Quotation;

Whereas, the bid form submitted by Golden Prince Hotel and Suites, specifically the first page with closing date of 20 November 2024 was attached;

Whereas, the RO 7 BAC made a clarification to the canvasser as to the bid submitted by Golden Prince Hotel and Suites;

Whereas, the canvasser made a clarification to Golden Prince Hotel and Suites as to the attached bid form;

Whereas, sales representative from Golden Prince Hotel and Suites confirmed their bids and informed the canvasser that the first page was mistakenly attached;

Whereas, Golden Prince Hotel and Suites sent an email for reconsideration addressed to RO 7 BAC as per attached;

Whereas, due to the urgency of the activity and only one qualified bidder for the procurement, RO 7 BAC granted the request for reconsideration of Golden Prince Hotel and Suites;

Whereas, after further bid evaluation, the RO-7 BAC declares Golden Prince Hotel and Suites with the Lowest Calculated and Responsive Quotation (LCRQ);

Now, THEREFORE, be it resolved as it is hereby resolved, the members of R07-BAC present during the deliberation unanimously recommend to HOPE that the Procurement of Venue including accommodation and meals during the Creative Industries Satellite Accounts Phase 2 Focus Group Discussions (FGDS) on Creative Economy of Visayas Cluster on 26 November 2024 be awarded to Golden Prince Hotel and Suites.
