RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (R07-BAC)
RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THAT THE
PROCUREMENT OF VENUE WITH ACCOMMODATION AND FOOD (AM & PM SNACKS,
BUFFET BREAKFAST, BUFFET LUNCH AND BUFFET DINNER) DURING THE SECOND LEVEL
TRAINING ON PALAY PRODUCTION SURVEY (PPS) AND CORN PRODUCTION SURVEY (CPS)
ON 17 TO 21 MARCH 2025 BE AWARDED TO CEBU BUSINESS HOTEL

Whereas, Philippine Statistics Authority (PSA) - Regional Statistical Services Office 7 needs to procure Venue with Accommodation and Food (AM & PM snacks, buffet breakfast, buffet lunch and buffet dinner) during the Second level training on Palay Production Survey (PPS) and Corn Production Survey (CPS) on 17 to 21 March 2025;

*Whereas, the Purchase Request (**PR No.0700-2025-03-018**) with an Approved Budget of Contract (ABC) of One Hundred Twenty-Two Thousand Six Hundred Fifty Pesos Only (Php122,650.00) was received by the Regional Office 7 Bids and Awards Committee (R07-BAC) on 06 March 2025;*

Whereas, as approved by the Head of the Procuring Entity (HOPE) through R07-BAC Resolution No. 0700-2025-02-R047A dated 05 February 2025, this procurement was done through Lease of Venue;

Whereas, R07-BAC received quotations from five (5) suppliers: 1) Cebu Business Hotel, 2) Golden Prince Hotel and Suites, 3) Duros Hotel Inc., 4) Golden Peak Hotel and Suites, and 5) Harolds Hotel and from two (2) other suppliers: 1) DepEd Ecotech Center, a government-owned establishment, which is not available and 2) Noble Hotel which only acknowledged receipt of the request, as stipulated in the abstract of quotation;

Whereas, during the opening of bids, R07-BAC considered the quotation submitted by Cebu Business Hotel as the Lowest Calculated Quotation (LCQ);

Whereas, after further bid evaluation, the R07-BAC declares Cebu Business Hotel with the Lowest Calculated and Responsive Quotation (LCRQ);

Now, THEREFORE, be it resolved as it is hereby resolved that the members of Regional Office 7 Bids and Awards Committee (R07-BAC) present during the deliberation unanimously recommend to the Head of the Procuring Entity (HOPE) that the procurement of Venue with Accommodation and Food (AM & PM snacks, buffet breakfast, buffet lunch and buffet dinner) during the Second level training on Palay Production Survey (PPS) and Corn Production Survey (CPS) on 17 to 21 March 2025 be awarded to **Cebu Business Hotel**.
