**RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (R07-BAC)  
RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THAT THE  
PROCUREMENT OF VENUE WITH ACCOMMODATION AND FOOD (AM & PM SNACKS AND  
BREAKFAST, LUNCH, AND DINNER) DURING THE SECOND LEVEL TRAINING FOR CROPS  
PRODUCTION SURVEY (CRPS) ON 4 MARCH TO 7 MARCH 2025 BE AWARDED TO GOLDEN  
PRINCE HOTEL AND SUITES**

*Whereas, Philippine Statistics Authority (PSA) - Regional Statistical Services Office 7 needs to procure Venue with Accommodation and Food (AM & PM snacks and breakfast, lunch, and dinner) during the Second Level Training for Crops Production Survey (CrPS) on 4 March to 7 March 2025;*

*Whereas, the Purchase Request (PR No.0700-2025-02-013) with an Approved Budget of Contract (ABC) of Seventy-One Thousand Seven Hundred Pesos Only (Php71,700.00) was received by the Regional Office 7 Bids and Awards Committee (R07-BAC) on 20 February 2025;*

*Whereas, as approved by the Head of the Procuring Entity (HOPE) through R07-BAC Resolution No. 0700-2025-02-R047A dated 05 February 2025, this procurement was done through Lease of Venue;*

*Whereas, R07-BAC received quotations from four (4) suppliers: 1) Golden Prince Hotel and Suites, 2) Golden Peak Hotel and Suites, 3) Duros Hotel Inc., and 4) DepEd Ecotech Center, a government-owned establishment, and from three (3) other suppliers: 1) Goldberry Suites and Hotel, which did not submit a quotation due to unavailability of the function room, 2) Palm Grass Hotel, which submitted the quotation online, and 3) Cebu Business Hotel, which only acknowledged receipt of the request, as stipulated in the abstract of quotation;*

*Whereas, during the opening of bids, R07-BAC considered the quotation submitted by Golden Prince Hotel and Suites as the Lowest Calculated Quotation (LCQ);*

*Whereas, after further bid evaluation, the R07-BAC declares Golden Prince Hotel and Suites with the Lowest Calculated and Responsive Quotation (LCRQ);*

**Now, THEREFORE, be it resolved as it is hereby resolved that the members of Regional Office 7 Bids and Awards Committee (R07-BAC) present during the deliberation unanimously recommend to the Head of the Procuring Entity (HOPE) that the procurement of venue with accommodation and food (AM & PM snacks and breakfast, lunch, and dinner) during the Second Level Training for Crops Production Survey (CrPS) on 4 March to 7 March 2025 be awarded to Golden Prince Hotel and Suites.**
