RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (R07-BAC)
RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THAT THE
PROCUREMENT OF VENUE WITH FOOD FOR THE CONDUCT OF 2025 MID-YEAR
PROVINCIAL PLANNING WORKSHOP (PPW) ON 02-03 JUNE 2025 OF PSA CEBU BE
AWARDED TO GOLDEN PRINCE HOTEL & SUITES.

Whereas, the Philippine Statistics Authority- Cebu Provincial Statistical Office (PSA Cebu PSO), Cebu City, Cebu needs to procure Venue with food for the conduct of 2025 Mid-year Provincial Planning Workshop;

Whereas, the Purchase Request (<u>PR No.0722-2025-05-056</u>) with an Approved Budget of Contract (ABC) Ninety-Seven Thousand Five Hundred Pesos Only (Ph97,500.00) was received by R07-BAC Secretariat on 16 May 2025;

Whereas, as approved by HOPE thru ROBAC Resolution No.0700-2025-05-R230 dated 21 May 2025, this procurement was done through Lease of Venue;

WHEREAS, (RO-7BAC) received quotations from three (3) qualified suppliers namely; 1) Golden Prince Hotel & Suites; 2) Azia Suites and Residencies and 3) One Central Hotel and one (1) non-availability from DepEd Ecotech Center a government-owned establishment as stipulated in the abstract of the quotation;

Whereas, on 28 May 2025, the RO7-BAC conducted a deliberation through video teleconferencing and considered the quotation submitted by Golden Prince Hotel & Suites as the Lowest Calculated Quotation (LCQ);

Whereas, upon careful evaluation, post qualification, and verification, RO7-BAC with the assistance of the Technical Working Group (TWG) declared **Golden Prince Hotel & Suites** with the Lowest Calculated and Responsive Quotation (LCRQ) having complied, responsive and eligible service provider;

Now, THEREFORE, be it resolved as it is hereby resolved, the members of R07-BAC present during the deliberation unanimously recommend to HOPE that the Procurement of Venue with Food for the conduct of 2025 Mid-year Provincial Planning Workshop of PSA Cebu be awarded to **Golden Prince Hotel & Suites.**
