**Invitation to Bid for
 PROCUREMENT AND DELIVERY OF 2015 CENSUS OF POPULATION (POPCEN 2015)
 MEALS FOR ANGELES CITY AND SAN JOSE DEL MONTE CITY**

1. The PHILIPPINE STATISTICS AUTHORITY (PSA)– Regional Statistical Services Office (RSSO) III, through the *General Appropriations Act of FY 2015* intends to apply the sum of **ONE MILLION THREE HUNDRED TWENTY-EIGHT THOUSAND FIVE HUNDRED PESOS (PhP1,328,500.00)** being the Approved Budget for the Contract (ABC) to payments for the hereunder project. The Bidding Documents Price (BDP) is Php1,000.00 per lot and the ABC is distributed as follows:

Bidders should have completed, within the last three years prior to the deadline for the submission and receipt of bids, a contract similar to the Project equivalent to at least twenty-five percent (25%) of the ABC per lot. The description of an Eligible Bidder is contained in Section II of the Bidding Documents, Instruction to Bidders (ITB).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary pass/fail criterion as specified in the Revised Implementing Rules and Regulations (RIRR) of RA 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizen/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino Citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

4. Bidders shall have the option of submitting a proposal on any lot or all lots. If the Bidder opts to bid for the two lots, only one Eligibility Requirements shall be submitted. Evaluation and award of contract will be undertaken on per lot basis. Bids received in excess of the ABC per lot shall be automatically rejected at bid opening.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity (psa.gov.ph) provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

6. The PSA RSSO III reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
