PROCUREMENT OF SECURITY SERVICES

1. The PHILIPPINE STATISTICS AUTHORITY (PSA)— Regional Statistical Services Office (RSSO) III, through the General Appropriations Act of FY 2015 intends to apply the sum of FOUR MILLION EIGHT HUNDRED SIXTY-FIVE THOUSAND ONE HUNDRED THIRTY PESOS (Php 4,865,130.00) being the Approved Budget for the Contract (ABC) to payments for the hereunder project, the ABC and Bidding Documents Price (BDP) distributed as follows:

- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary pass/fail criterion as specified in the Revised Implementing Rules and Regulations (RIRR) of RA 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizen/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino Citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

- 4. Bidders shall have the option of submitting a proposal on any lot or all lots. If the Bidder opts to bid for the seven lots, only one Eligibility Requirements shall be submitted. Evaluation and award of contract will be undertaken on per lot basis. Bids received in excess of the ABC per lot shall be automatically rejected at bid opening.
