## Section II. Instructions to Bidders

## Notes on the Instructions to Bidders

This Section on the Instruction to Bidders (ITB) provides the information necessary for bidders to prepare responsive bids, in accordance with the requirements of the Procuring Entity. It also provides information on bid submission, eligibility check, opening and evaluation of bids, post-qualification, and on the award of contract.

## JANITORIAL SERVICES FOR RSSO MIMAROPA, PSO MARINDUQUE, PSO OCCIDENTAL MINDORO, PSO ORIENTAL MINDORO, PSO PALAWAN AND PSO ROMBLON

1. The Philippine Statistics Authority (PSA) RSSO MIMAROPA, through the General Appropriations Act FY 2025, intends to apply the sum of One Million Two Hundred Ninety Thousand Twenty-Eight Pesos and 20/100 Only (P 1,290,028.20) being the ABC to payments under the contract for Janitorial Services for RSSO MIMAROPA, PSO Marinduque, PSO Occidental Mindoro, PSO Oriental Mindoro, PSO Palawan and PSO Romblon for January 01, 2025 to December 31, 2025.

Bids received in excess of the ABC shall be automatically rejected at bid opening.

- 2. The Philippine Statistics Authority RSSO MIMAROPA now invites bids for the above Procurement Project. Delivery of the Goods is required from January 01, 2025 to December 31, 2025 for the Janitorial Services for RSSO MIMAROPA, PSO MARINDUQUE, PSO OCCIDENTAL MINDORO, PSO ORIENTAL MINDORO, PSO PALAWAN AND PSO ROMBLON.
- 3. Bidders should have completed, within **Three (3) Years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
  - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

The **Philippine Statistics Authority RSSO MIMAROPA** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
