



## **INVITATION TO BID PROCUREMENT ON SUPPLY, DELIVERY AND MANAGED SERVICES OF 2,800 REGISTRATION KITS FOR THE PHILIPPINE IDENTIFICATION SYSTEM (PHILSYS)**

1. The Philippine Statistics Authority (PSA), through the *General Appropriations Act of 2021* intends to apply the sum of **Seven Hundred Fifty-Six Million Pesos (Php 756,000,000.00) inclusive of 12% Value Added Tax (VAT) being the Approved Budget Contract (ABC)** to payments under the contract for ***Procurement on Supply, Delivery and Managed Services of 2,800 Registration Kits for the Philippine Identification System (Philsys)***. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The PSA now invites bids for the above Procurement Project. Delivery of the Goods is required ninety (90) days after the receipt by winning bidder of the Notice to Proceed (NTP). Bidders should have completed, **within ten (10) years** the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from the PSA and inspect the Bidding Documents at the address given below during working hours from 8:00 A.M. to 5 P.M, weekdays except holidays.

**Pesos (Php 75,000.00).** The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person or through electronic means.

6. The PSA will hold a Pre-Bid Conference<sup>1</sup> on **Thursday, March 11, 2021, 2:00PM** at 17th floor, Cyberpod Centris Three, Eton Centris, EDSA corner Quezon Avenue, Quezon City, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below **on or before Thursday, March 25, 2021, at 12:00 PM**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **Thursday, March 25, 2021, at 02:00 PM** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The PSA reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
