## Invitation to Bid

### Procurement for the Printing, Supply and Delivery/Shipment of 2018 Family Income and Expenditure Survey (FIES) Visit 2 Questionnaires and Enumerator's Manual (Reposting)

1. The Philippine Statistics Authority (PSA), through the 2018 General Appropriations Act, intends to apply the sum of **Eight Million Five Hundred Thirty Six Thousand Pesos (P8,536,000.00)**, being the Approved Budget for the Contract (ABC) to payments of Printing, Supply and Delivery/Shipment of 2018 FIES Visit 2 Questionnaires and Enumerator's Manual. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The PSA now invites bids for the Procurement for the Printing, Supply and Delivery/Shipment of 2018 FIES Visit 2 Questionnaires and Enumerator's Manual for the 2018 FIES. All items must be received **NOT later than 26 November 2018**. Bidders should have completed, within the last three years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary pass/fail criterion as specified in the Revised Implementing Rules and



Regulations (IRR) of RA 9184, otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from the PSA-BAC Secretariat and inspect the Bidding Documents at the address given below during 9:00 a.m. to 5:00 p.m.
5. A complete set of Bidding Documents may be acquired by interested bidders starting **19 September 2018** from the address below and upon payment of the applicable fee as indicated above. The Bidding Documents shall be received personally by the prospective bidder or his duly authorized representative upon presentation of proper identification document.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than **12 October 2018, 5:00 P.M..**

6. The PSA-BAC will hold a Pre-Bid Conference on **01 October 2018, 3:00 P.M.** at the FAS Training Room, 11/F Centris Cyberpod One, EDSA cor. Quezon Avenue, Diliman, Quezon City, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the PSA, 11<sup>th</sup> Floor, Centris Cyberpod One, EDSA cor. Quezon Ave., Diliman, Quezon City, on or before **15 October 2018, 10:30A.M..** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bids will be opened in the presence of the bidder's representatives who choose to attend at the address below. Late bids shall not be accepted.
