INVITATION TO BID FOR PROCUREMENT OF PRE-REGISTRATION TABLET AND WEB-BASED SMS BROADCAST SERVICES FOR THE PHILSYS PROJECT

1. The Philippine Statistics Authority (PSA), through the **2019 Continuing Appropriation**, intends to apply the sum of **One Hundred Twenty Million Pesos** (PhP120,000,000.00) for Lot 1 and through **2020 General Appropriations Act** for **Twelve Million Five Hundred Thousand Pesos** (PhP12,500,000.00) for the duration of 12 months for Lot 2. Being the Approved Budget for the Contract (ABC) to payment for the Lots of Procurement of Pre-Registration Tablet and Web-Based SMS Broadcast Services for the PhilSys Project. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Philippine Statistics Authority (PSA) now invites bids for **Procurement of Pre-Registration Tablet and Web-Based SMS Broadcast Services for the Philsys project**. Delivery of the Goods is required **within forty-five (45) calendar days for Pre-Registration Tablet for PhilSys Project (Lot 1) and thirty (30) calendar days for Web-Based SMS Broadcast services for the PhilSys Project (Lot 2), upon receipt of Notice to Proceed**. The **Contract duration for Lot 2 (Web-Based SMS Broadcast Services for the PhilSys Project) is twelve (12) months**. Bidders should have completed, **within five (5) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from the PSA and inspect the Bidding Documents at the address given below during office hours.
5. A complete set of Bidding Documents may be acquired by interested Bidders on 15 July 2020 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the following amounts:

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the PSA, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The PSA-BAC will hold a Pre-Bid Conference on **23 July 2020, 1:30 P.M.**, at **17th Floor, Cyberpod Centris Three, Eton Centris, EDSA corner Quezon Avenue, Quezon City**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **4 August 2020, 1:30 P.M.** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **4 August 2020, 2:00 P.M.** at **17th Floor, Cyberpod Centris Three, Eton Centris, EDSA corner Quezon Avenue, Quezon City**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The PSA reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
