**Invitation to Bid for
Supply and Delivery of Various IT Hardware and Software for 2015 Census of Population**

1. The **PHILIPPINE STATISTICS AUTHORITY (PSA)**, through Republic Act 10651 or the 2015 General Appropriations Act (GAA), intends to apply the sum of **Fifty Eight Million Five Hundred Forty One Thousand Pesos (PhP58,541,000.00)** being the Approved Budget for the Contract (ABC) to payments for the hereunder projects, and the ABC distributed as follows:

- Bidders shall have the option of submitting a proposal on any lot or all lots. If the Bidder opts to bid for the two lots, only one Eligibility Requirements shall be submitted. Evaluation and award of contract will be undertaken on per Lot basis. Bids received in excess of the ABC per lot shall be automatically rejected at bid opening.
- Bidders should have completed, within **the last three years prior to the deadline for the submission and receipt of bids, a single contract similar to this Project equivalent to at least fifty percent (50%) of the ABC per lot.** The description of an Eligible Bidder is contained in Section 11 of the Bidding Documents, Instruction to Bidders (ITB).
- Bidding will be conducted through open competitive bidding procedures using a non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of RA 9184, otherwise known as the "Government Procurement Reform Act". Bidding is open to all interested Bidders subject to the conditions for eligibility provided in the IRR of RA9184.
