**Invitation to Bid for
Procurement of UMID CVS System Maintenance**

The **PHILIPPINE STATISTICS AUTHORITY (PSA)**, through the FY 2015 Budget, Current Appropriations (RA 10651) intends to apply the sum of **Fifty Five Million pesos (PhP55,000,000)** being the Approved Budget for the Contract (ABC) for the first year of the three (3) year period to payments for the hereunder project, and the ABC as follows:

Bidders should have completed, within the last three years prior to the deadline for the submission and receipt of bids, a single contract similar to this Project equivalent to at least fifty percent (50%) of the ABC per lot. The description of an eligible bidder is contained in Section II of the Bidding Documents, Instruction to Bidders (ITB).

Bidding will be conducted through open competitive bidding procedures using a non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of RA 9184, otherwise known as the "Government Procurement Reform Act". Bidding is open to all interested bidders, subject to the conditions for eligibility provided in the IRR of RA 9184.
