  - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from the PSA Bids and Awards Committee (BAC) Secretariat and inspect the Bidding Documents at the address given below during 8:00 AM to 5:00 PM except weekends and holidays.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on 18 August 2022 from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php5,000.00. The Procuring Entity shall allow the bidder to present its proof of payment for the fees be presented in person.
- 6. The *PSA-BAC* will hold a Pre-Bid Conference on **26** August **2022** at **2:00** PM through video conferencing or webcasting via the Zoom platform which shall be open to prospective bidders. - 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9. Bid opening shall be on **2:00 PM of 07 September 2022**. The venue of the activity will be announced accordingly.

The *PSA* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
