Price quotattion/s must be valid for a period of thirty (30) calendar days from the date of submission. Price guotation/s, to be denominated in Philippine peso, shall include all taxes, duties and/or levies payable. 3 4 Quotations exceeding the ABC shall be rejected. Award of contract shall be made to the lowest calculated and responsive bid (LCRB). 6 Any interlineations, erasures or overwriting shall be valid only if they are signed or initialed by you or your duly authorized representative. In case of two or more bidders are determined to have submitted the LCRB, the PSA shall adopt and employ "draw lots" as the tie-breaking 7 method to finally detrmine the single winning bidder in accordance with GPPB Circular 06-2005.
