**RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (R07-BAC)**  
**RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THAT THE**  
**PROCUREMENT OF BOLTLESS METAL RACK FOR THE NEW DATA PROCESSING CENTER**  
**OF PSA CEBU BE AWARDED TO JCE MARKETING.**

*Whereas, Philippine Statistics Authority (PSA) - Regional Statistical Services Office 7 under Republic Act No. 10625, otherwise known as the Philippine Statistical Act of 2013 is mandated to conduct periodic censuses on population, housing, agriculture, fisheries, business, industry, and other sectors of the economy;*

*Whereas, the Philippine Statistics Authority- Cebu Provincial Statistical Office (PSA Cebu PSO), Cebu City, Cebu needs office equipment, boltless metal rack, to be used in the new Data Processing Center;*

*Whereas, the Purchase Request (**PR No.0722-2025-04-036**) with an Approved Budget of Contract (ABC) One Hundred Thirty Thousand Pesos Only (Php130,000.00) was received by R07-BAC Secretariat on 23 April 2025;*

*Whereas, as approved by HOPE thru ROBAC Resolution No.0700-2025-04-R175 dated 24 April 2025, this procurement was done through Small Value Procurement;*

*Whereas, this procurement was posted on the Philippine Government Electronic Procurement System (PhilGEPS) website, Philippine Statistics Authority (PSA) website, and in a conspicuous place in compliance to the 2016 Revised Implementing Rules and Regulations of Republic Act 9184 otherwise known as the Government Procurement Act on 24 April 2025 with reference no. 11987585;*

*Whereas, (RO-7BAC) received quotations from four (4) qualified suppliers namely; **1) SECC Computer Sales, Services & Enterprises; 2) JCE Marketing; 3) Cebu Office Furniture Shop; and 4) Glow-Getter Consumer Goods Trading** as stipulated in the abstract of the quotation;*

*Whereas, on **30 April 2025**, the R07-BAC conducted a deliberation through **video teleconferencing** and considered the quotation submitted by **JCE Marketing** as the Lowest Calculated Quotation (LCQ) but subject for Provincial Technical Working Group (TWG) Verification to assess their compliance with the technical specifications stated on the request for quotation of their offered item;*

*Whereas, on **14 May 2025**, R07-BAC conducted another regular deliberation through video teleconferencing and upon the assessment of the TWG report, R07-BAC noted that it was inconclusive and advised for the improvement of the report;*

*Whereas, on 20 May 2025, R07-BAC conducted a special deliberation through messenger and upon careful evaluation, post qualification, and verification, R07-BAC with the assistance of the Technical Working Group (TWG) declared **JCE MARKETING** with the Lowest Calculated and Responsive Quotation (LCRQ) having complied with all the technical specifications as stated in the revised report of the Provincial Technical Working Group with TWG Report No.**2025-05-008**;*

***Now, THEREFORE,** be it resolved as it is hereby resolved, the members of R07-BAC present during the deliberation unanimously recommend to the HoPE that the Procurement of Boltless Metal Rack for the New Data Processing of PSA Cebu be awarded to **JCE MARKETING**.*
