RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (R07-BAC) RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) FOR THE PROCUREMENT OF REGULAR SUPPLIES FOR THE 4TH QUARTER OF 2024 OF PSA RSSO VII FOR ADMINISTRATIVE AND STATISTICAL MATTERS FOR LOT-4 CUSTOMIZED ITEMS BE AWARDED TO JCE MARKETING.

Whereas, the Philippine Statistics Authority (PSA)-Regional Statistical Services
Office 7 needs to procure Regular Supplies for the 4th Quarter of 2024 of PSA RSSO
VII for Administrative and Statistical Matters for Lot-4 Customized Items;

Whereas, the Purchase Request (PR No. 0700-2024-09-062) with an Approved Budget of the Contract (ABC) for Lot -4 Customized Items of Forty -Four Thousand-One Hundred- Seventy- Five-Pesos Only (Php44,175.00) was received by R07-BAC Secretariat on 17 September 2024;

Whereas, as approved by HOPE thru RO7-BAC Resolution No. 0700-2024-09-R654 dated 18 September 2024, this procurement was done through Small Value Procurement:

Whereas, this procurement was posted on 04 October 2024 at the Philippine Government Electronic Procurement System (PhilGEPS) website with reference no.11320351, Philippine Statistics Authority (PSA) website, and in at least one (1) conspicuous place;

Whereas, RO7-BAC received quotations from two (2) qualified suppliers namely; 1.) JCE Marketing and one (1) who acknowledge only which is Visayan Educational Supply Corporation;

Whereas, during the opening of bids, the R07-BAC considered the quotation submitted by JCE Marketing as the Single Calculated & Responsive Bidder;

Whereas, after evaluation, the R07-BAC declares JCE Marketing with the Single Calculated and Responsive Bidder:

Now, THEREFORE, be it resolved as it is hereby resolved that the members of the Region 7 Bids and Awards Committee (R07-BAC) present during the deliberation unanimously recommend to the Head of the Procuring Entity (HoPE) that the procurement of Regular Supplies for the 4th Quarter of 2024 of PSA RSSO VII for Administrative and Statistical Matters for Lot-4 Customized Items be awarded to JCE Marketing.
