RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (RO7-BAC) RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THAT THE PROCUREMENT OF VENUE INCLUDING ACCOMMODATION WITH MEALS DURING THE CONDUCT OF THE 2024 FUNCTIONAL LITERACY, EDUCATION, AND MASS MEDIA SURVEY REGIONAL DISSEMINATION FORUM ON 29 MAY 2025 BE AWARDED TO DUROS HOTELS INC./CEBU QUINCENTENNIAL HOTEL

Whereas, Philippine Statistics Authority (PSA) - Regional Statistical Services Office 7 needs to procure Venue including accommodation with meals during the conduct of the 2024 Functional Literacy, Education, and Mass Media Survey Regional Dissemination Forum on 29 May 2025;

Whereas, the Purchase Request (<u>PR No.0700-2025-05-036</u>) with an Approved Budget of Contract (ABC) of Ninety-Nine Thousand Seven Hundred Fifty Pesos Only (Php99,750.00) was received by the Regional Office 7 Bids and Awards Committee (RO7-BAC) on 20 May 2025;

Whereas, as approved by the Head of the Procuring Entity (HOPE) through RO7-BAC Resolution No. 0700-2025-02-R047A dated 05 February 2025, this procurement was done through Lease of Venue;

Whereas, the RO7-BAC received quotations from two (2) suppliers: 1) Duros Hotels Inc./Cebu Quincentennial Hotel, and 2) Summit Galleria Cebu; and not available from two (2) other suppliers: 1) Mezzo Hotel and 2) Deped Ecotech Center, a government-owned establishment, as stipulated in the abstract of quotation;

Whereas, during the opening of bids, the RO7-BAC considered the quotation submitted by Duros Hotels Inc./Cebu Quincentennial Hotel as the Lowest Calculated Quotation (LCQ), subject for Technical Working Group verification as a first-time supplier of Philippine Statistics Authority Region 7;

Whereas, based on the verification with TWG Report No. 2025-05VR-013 dated 24 May 2025 the Technical Working Group of PSA RSSO 7 BAC have ascertained that Duros Hotels Inc./Cebu Quincentennial Hotel is deemed compliant with the requirements of this procurement;

Whereas, after further evaluation, the RO7-BAC declares Duros Hotels Inc./Cebu Quincentennial Hotel with the Lowest Calculated and Responsive Quotation (LCRQ);

Now, THEREFORE, be it resolved as it is hereby resolved, that the members of Regional Office 7 Bids and Awards Committee (RO7-BAC), present during the deliberation unanimously recommend to the Head of the Procuring Entity (HOPE) that the procurement of Venue including accommodation with meals during the conduct of the 2024 Functional Literacy, Education, and Mass Media Survey Regional Dissemination Forum on 29 May 2025 be awarded to **Duros Hotels Inc./Cebu Quincentennial Hotel**. .
