

Contract Agreement Form


THIS AGREEMENT made on the 1st day of September 2023 between **PHILIPPINE STATISTICS AUTHORITY-REGIONAL STATISTICAL SERVICES OFFICE NO. 7** of the Philippines (hereinafter called "the Entity") of the one part and **PANALAY TAILORING of Lovely Homes Subd., Mohon, Talisay City** (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., [*Procurement of Supply and Delivery of Operational Supplies and Materials for the 2022 Census of Agriculture and Fisheries (CAF) for Philippine Statistics Authority -Region VII*] and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of *Sixty-Six Thousand Six Hundred Sixty-Two Pesos Only (PHP66,662.00) for LOT 33- Customized Items A for RSSO VII* (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, Warranty Security and Liquidated Damages required in Section 68 of the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184, shall likewise form part of the Contract.**
3. In consideration for the sum of *Sixty-Six Thousand Six Hundred Sixty-Two Pesos Only (PHP66,662.00) for LOT 33- Customized Items A for RSSO VII* or such other sums as may be ascertained, **PANALAY TAILORING** agrees to *provide the goods and services and to remedy defects therein conformity in all respects with the provisions of the contract in accordance with his/her/its Bid.*
4. The **PHILIPPINE STATISTICS AUTHORITY-7 (PSA-7)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
