RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (RO7-BAC) RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THAT THE PROCUREMENT OF VENUE WITH ACCOMMODATION AND FOOD (AM & PM SNACKS WITH BUFFET MEALS-BREAKFAST, LUNCH AND DINNER) DURING THE SOCD GROUP LEARNING SESSION: MID-YEAR REVIEW AND EVALUATION OF STATISTICAL OPERATIONS FOR THE 1ST QUARTER 2025 ON 4-6 JUNE 2025 BE AWARDED TO V8 MOUNTAIN RESORT CORPORATION/MIST MOUNTAIN RESORT

Whereas, Philippine Statistics Authority (PSA) - Regional Statistical Services Office 7 needs to procure Venue with Accommodation and Food (AM & PM snacks with buffet meals-breakfast, lunch, and dinner) during the SOCD Group Learning Session: Mid-Year Review and Evaluation of Statistical Operations for the 1st quarter 2025 on 4-6 June 2025;

Whereas, the Purchase Request (<u>PR No.0700-2025-05-043)</u> with an Approved Budget of Contract (ABC) of One Hundred Twenty-Two Thousand Eight Hundred Pesos Only (Php122,800.00) was received by the Regional Office 7 Bids and Awards Committee (RO7-BAC) on 30 May 2025;

Whereas, as approved by the Head of the Procuring Entity (HOPE) through RO7-BAC Resolution No. 0700-2025-05-R268 dated 30 May 2025, this procurement was done through Lease of Venue;

Whereas, the RO7-BAC received quotation from one (1) supplier, 1) V8 Mountain Resort Corporation/Mist Mountain Resort; and not available from three (3) other suppliers: 1) One Tectona Hotel, 2) Sermon on the Mount Retreat Resort, and 3) Deped Ecotech Center, a government-owned establishment, as stipulated in the abstract of quotation;

Whereas, during the opening of bids, the RO7-BAC considered the quotation submitted by V8 Mountain Resort Corporation/Mist Mountain Resort as the Single Calculated Quotation (SCQ), subject for Technical Working Group verification as a first-time supplier of Philippine Statistics Authority Region 7;

Whereas, based on the verification with TWG Report No. 2025-06VR-016 dated 03 June 2025 the Technical Working Group of PSA RSSO 7 BAC have ascertained that V8 Mountain Resort Corporation/ Mist Mountain Resort is deemed compliant with the requirements of this procurement;

Whereas, after further evaluation, the RO7-BAC declares V8 Mountain Resort Corporation/Mist Mountain Resort with the Single Calculated and Responsive Quotation (SCRQ);

Now, THEREFORE, be it resolved as it is hereby resolved, that the members of Regional Office 7 Bids and Awards Committee (RO7-BAC), present during the deliberation unanimously recommend to the Head of the Procuring Entity (HOPE) that the procurement of Venue with Accommodation and Food (AM & PM snacks with buffet meals-breakfast, lunch, and dinner) during the SOCD Group Learning Session: Mid-Year Review and Evaluation of Statistical Operations for the 1st quarter 2025 on 4-6 June 2025 be awarded to **V8 Mountain Resort Corporation/Mist Mountain Resort.**
