**RESOLUTION OF THE REGIONAL OFFICE 7 BIDS AND AWARDS COMMITTEE  
(RO 7 BAC) RECOMMENDING TO THE HEAD OF PROCURING ENTITY  
HOPE) THAT THE PROCUREMENT OF SUPPLY AND DELIVERY OF  
PURIFIED DRINKING WATER FOR THE PERIOD JANUARY TO DECEMBER  
2025 OF PSA-CEBU BE AWARDED TO NATUREFRESH PURIFIED DRINKING  
WATER**

**Whereas**, the Philippine Statistics Authority (PSA)- Cebu Provincial Statistical Office, Cebu City, Cebu, is in need of Supply and Delivery of Purified Drinking Water for the period January to December 2025;

**Whereas**, an approved Purchase Request with **PR No.0722-2024-12-153** was received by the Regional Office 7 Bids and Awards Committee (RO 7 BAC) Secretariat;

**Whereas**, the Approved Budget for the Contract (ABC) of the said procurement is **SIXTY THOUSAND PESOS ONLY (Php 60,000.00)**;

**Whereas**, this procurement was done through an Alternative Method of Procurement – Small Value Procurement;

**Whereas**, this procurement was posted on the Philippine Government Electronic Procurement System (PhilGEPS) website, Philippine Statistics Authority (PSA) website, as the amount is above Php 50,000.00 per Section 54 of the 2016 Revised IRR;

**Whereas**, during the posting period, the RO 7 BAC sent Request for Quotations to at least three (3) PhilGEPS registered establishments, in which the RO 7 BAC received **four (4)** quotations as enumerated in the Abstract of Quotation;

**Whereas**, on **15 January 2025**, the RO 7 BAC conducted a deliberation through virtual teleconferencing via Google Meet and considered the quotation submitted by **NATUREFRESH PURIFIED DRINKING WATER** as the Lowest Calculated Quotation (LCQ) and is subject for Technical Working Group (TWG) Verification as to the availability of documentary requirements;


**Whereas**, on **22 January 2025**, the RO7-BAC conducted a deliberation through virtual teleconferencing via Google Meet and presented the **TWG Report No. 2025-01-001** for **NATUREFRESH PURIFIED DRINKING WATER**, with findings that the documents are readily available;

**Whereas**, upon careful evaluation, RO7-BAC unanimously determined that **NATUREFRESH PURIFIED DRINKING WATER** submitted the Lowest Calculated and Responsive Quotation (LCRQ), having fully complied with all the technical specifications;


**Now, THEREFORE**, be it resolved as it is hereby resolved that the majority of the members of the Region Office 7 Special Bids and Awards Committee (RO 7 BAC) recommend to the Head of the Procuring Entity (HOPE) that this procurement be awarded to **NATUREFRESH PURIFIED DRINKING WATER**;
