### Guidelines on the Conduct of Virtual Pre-Bid Conference for the "Procurement of Consultancy Services as Systems Integrator for the Supply, Delivery Installation, and Maintenance of the Philippine Identification System (PhilSys)"

# A. To Join the Pre-Bid Conference

- Shortlisted bidders may send the following details to the BAC Secretariat at <u>bac-secretariat@psa.gov.ph;</u>
  - Name of Authorized Representative(s)
  - Company Name
  - Contact Number and Email Address
- The authorized representative/s of the shortlisted bidders will be provided by the BAC Secretariat with the Webex Meeting ID and password after receipt of the attendance confirmation with those details as enumerated above;
- 3) The authorized representative/s must select **Join meeting** in the Webex email invitation to join the pre-bid conference. After clicking the Join button, they will be able to see and hear the people in the meeting.
- 4) The authorized representatives should make themselves available10 minutes before the start of the pre-bid conference.

## **B.** Attendance to the Pre-bid Conference

1) The authorized representative/s must identify themselves by typing in the chat box their name/s and the company they are representing;



- 2) Authorized representative/s of the shortlisted bidders will be muted at the start of the pre-bid conference;
- The authorized representative/s will be given time to raise their queries for every section of the Bidding Documents that will be discussed;
- 4) The authorized representative/s of the shortlisted bidders, upon being acknowledged by the BAC Chairperson, must state their name and company before asking a question or commenting;
- 5) The authorized representative/s must wait for a participant to finish before speaking;
- 6) All are enjoined to be fully present for the whole duration of the pre-bid conference.
