

## Regional Bids and Awards Committee Resolution Resolution No. 0700-2024-08-R602-RSSO 24 August 2024

RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (R07-BAC) RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THAT THE PROCUREMENT OF VENUE INCLUDING FOOD (AM AND PM SNAKCS, BUFFET BREAKFAST, BUFFET LUNCH, AND BUFFET DINNER) AND ACCOMMODATION DURING THE CONDUCT OF THE SECOND LEVEL TRAINING ON 2024 OCCUPATIONAL WAGE SURVEY (2024 OWS) AND 2023/2024 INTEGRATED SURVEY ON LABOR AND EMPLOYMENT (2023/2024 ISLE) BE AWARDED TO GOLDEN PRINCE HOTEL AND SUITES.

Whereas, Philippine Statistics Authority (PSA) - Regional Statistical Services Office 7 needs to procure Venue including Food (AM and PM snacks, buffet breakfast, buffet lunch, and buffet dinner) and Accommodation during the Conduct of the Second Level Training on 2024 Occupational Wage Survey (2024 OWS) and 2023/2024 Integrated Survey on Labor and Employment (2023/2024 ISLE);

Whereas, the Purchase Request (<u>PR No.0700-2024-08-051</u>) with an Approved Budget of Contract (ABC) One Hundred Fifty-Six Thousand Eight Hundred Twenty Pesos Only (Php156,820.00.00) was received by R07-BAC Secretariat on 20 August 2024.

Whereas, as approved by HOPE thru ROBAC Resolution No.0700-2024-08-R593 dated 20 August 2024, this procurement was done through Lease of Venue;

WHEREAS, (RO-7BAC) received quotations from three (2) qualified suppliers namely; 1) One Central Hotel, and 2) Golden Prince Hotel and Suites and two (2) acknowledgement receipt from 1) The Noble Hotel and 2) Diamond Suites and Residences and one (1) not available from Deped Ecotech Center a government-owned establishment as stipulated in the abstract of the quotation;

Whereas, during the opening of bids, RO-7 BAC considered the quotation submitted by Golden Prince Hotel and Suites as the Lowest Calculated Quotation (LCQ);

Whereas, after further bid evaluation, the RO-7 BAC declares Golden Prince Hotel and Suites with the Lowest Calculated and Responsive Quotation (LCRQ);

Now, THEREFORE, be it resolved as it is hereby resolved, the members of R07-BAC present during the deliberation unanimously recommend to HOPE that the Procurement of Venue including Food (AM and PM snacks, buffet breakfast, buffet lunch, and buffet dinner) and Accommodation during the Conduct of the Second Level Training on 2024 Occupational Wage Survey (2024 OWS) and 2023/2024 Integrated Survey on Labor and Employment (2023/2024 ISLE) be awarded to Golden Prince Hotel and Suites.
