Whereas, the Region 7 Bids and Awards Committee (R07-BAC) received three (3) qualified bid forms from registered establishment namely:1.)Panda Tea Garden Suites, 2.) Reynas the Haven & Suites and 3.)J'J 'S Foodland Corporation;

Whereas, during the opening of bids, R07-BAC declared submitted by Panda Tea Garden Suite as the Lowest Calculated Quotation (LCQ);

Whereas, after thorough evaluation, the R07-BAC declared the quotation submitted by Panda Tea Garden Suite as the Lowest Calculated and Responsive Quotation (LCRQ);
