RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (R07-BAC)
RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THAT THE
PROCUREMENT OF VENUE WITH ACCOMMODATION AND FOOD (AM & PM SNACKS,
BUFFET BREAKFAST, LUNCH AND DINNER) DURING THE CONSULTATIVE
WORKSHOP FOR THE CRAFTING OF THE IMPLEMENTING RULES AND REGULATIONS
(IRR) FOR THE PENCAS ACT - VISAYAS CLUSTER ON 11 to 13 MARCH 2025 BE
AWARDED TO GOLDEN PRINCE HOTEL AND SUITES

Whereas, Philippine Statistics Authority (PSA) - Regional Stat0istical Services Office 7 needs to procure Venue with accommodation and food (AM & Pm snacks, buffet breakfast, lunch and dinner) during the Consultative Workshop for the Crafting of the Implementing Rules and Regulations (IRR) for the Pencas Act - Visayas Cluster on 11 to 13 March 2025;

Whereas, the Purchase Request (<u>PR No. 0700-2025-02-014</u>) with an Approved Budget of Contract (ABC) of Two Hundred Ninety-Nine Thousand Eight Hundred Pesos Only (Php299,800.00) was received by the Regional Office 7 Bids and Awards Committee (R07-BAC) on 17 February 2025;

Whereas, as approved by the Head of the Procuring Entity (HOPE) through RO7-BAC Resolution No.0700-2025-02-R047A dated 05 February 2025, this procurement was done through Lease of Venue;

Whereas, RO7-BAC received quotations from two (2) suppliers: 1) Golden Prince Hotel and Suites and 2) Duros Hotel Inc. and from three (3) other suppliers:1) Goldberry Hotel and Suites, which did not submit a quotation due to unavailability of the function room, 2) Not available from Deped Ecotech Center, a government-owned establishment, and 3) One Central Hotel which only acknowledged receipt, as stipulated in the abstract of quotation;

Whereas, during the opening of bids, RO7-BAC considered the quotation submitted by Golden Prince Hotel and Suites as the Lowest Calculated Quotation (LCQ);

Whereas, after further bid evaluation, the RO7-BAC declares Golden Prince Hotel and Suites with the Lowest Calculated and Responsive Quotation (LCRQ);

Now, THEREFORE, be it resolved as it is hereby resolved that the members of Regional Office 7 Bids and Awards Committee (R07-BAC) present during the deliberation unanimously recommend to the Head of the Procuring Entity (HOPE) that the procurement of Venue with accommodation and food (AM & PM snacks, buffet breakfast, lunch and dinner) during the Consultative Workshop for the Crafting of the Implementing Rules and Regulations (IRR) for the Pencas Act - Visayas Cluster on 11 to 13 March 2025 be awarded to Golden Prince Hotel and Suites.
