- 2 Delivery period: before August 29, 2025.
- 3 Evaluation of bids will be conducted on a "per lot" basis. Additionally, for Lease of Real Property and Venue as Method of Procurement, passing rate of 85% and the bidders shall be evaluated using the criteria on Annex H of the 2016 Revised IRR of RA 9184.
- 4 Price validity shall be for a period of sixty (60) calendar days upon date of submission of quotation.
